OBJECTIVES AND INVESTMENT POLICY

Investment Objective

To generate income and some growth over the long term (5 years or more) by investing in Emerging Market equities (company shares).

Performance Target: To achieve the return of the MSCI Emerging Markets Index plus 2% per annum before charges with a yield greater than that of this index. The performance target is the level of performance that the management team hopes to achieve for the fund. There is however no certainty or promise that they will achieve the performance target.

The ACD believes this is an appropriate target for the fund based on the investment policy of the fund and the constituents of the index.

Investment Policy

Portfolio Securities

- The fund will invest at least 70% in equities and equity related securities of companies listed, incorporated or domiciled in Emerging Market countries, or companies that derive a significant proportion of their revenues or profits from Emerging Market operations or have a significant proportion of their assets there.
- Emerging Markets include Asian, Eastern European, Middle Eastern,
- African or Latin American countries.

Management Process














- The Fund seeks to track the performance of the FTSE U.K. Equity Income Index (the "Index").
- The Fund is a passive fund.
- The Index consists of common shares of companies listed on the London Stock Exchange's main market, that are expected to pay dividends that generally are higher than average.
- · The Fund attempts to:
- 1. Track the performance of the Index by investing in all constituent shares of the Index in the same proportion as the Index.
- 2. Remain fully invested except in extraordinary market, political or similar conditions
- The Fund may invest in financial derivative instruments that could increase
 or reduce exposure to underlying assets and result in greater fluctuations
 of the Fund's net asset value. Some derivatives give rise to increased
 potential for loss where the Fund's counterparty defaults in meeting its
 payment obligations.
- The currency of the share class is GBP.

- The Fund may engage in short term secured lending of its investments to certain eligible third parties. This is used as a means of generating additional income and to off-set the costs of the Fund.
- The Fund may not be appropriate for short-term investment.


