Portfolio objective

Selecting funds that place an emphasis on ethical investment criteria whilst providing a long-term capital return in excess of the UT Flexible Investment Retail sector.

Investment approach


Funds are selected by applying a filter to identify those that meet our strict ethical criteria. The objective is achieved by using a diverse investment approach across a variety of geographical regions and industrial sectors, exchanging a higher level of risk with the potential for a greater rate of return. The performance of all the funds in the portfolio is constantly monitored and formally reviewed on a quarterly basis by our investment committee.

Portfolio manager's commentary

Challenging market conditions over the quarter were especially difficult for investments with an ethical theme as oil prices rose in reaction to events in the Middle East. Alongside natural resources, areas such as India and Japan were some of the better performers but they remain difficult to invest in with respect to the portfolio objective. The cash and lowest risk bond holdings were the bright spots in an otherwise disappointing quarter.

We made one main change this quarter which was to introduce a holding in the Absolute Return sector via a fund that meets our ethical criteria and should also provide an uncorrelated return relative to the other funds used in the portfolio. This is a reflection of our desire to add a layer of defence in the event that the final months of the year see an increase in volatility. To fund this change we reduced the allocation to both UK and Global Equities. Full details of the changes being recommended are outlined on the Fund Changes summary which is available on our website.




